

# ***New Media Broadcasters, Inc.***

## **Official Rules – 2019 WWE Missoula Ticket Promotion – Effective June 10<sup>th</sup>, 2019**

- 1) To Participate. No purchase necessary. From Monday June 10<sup>th</sup> through Sunday June 16<sup>th</sup>, 2019 listeners will be invited on the air to call-in to register for prizes. Listeners also invited to register online at HI-Line Today dot com by answering a WWE Trivia question daily. Listeners may register only once per day on air per station and online. On Monday, June 17<sup>th</sup>, 2019 twelve winners will be chosen. Winners will be notified on the air and via telephone that he or she has won. This is a local contest. Qualifiers will be taken from various cities where New Media Broadcasters' radio stations on air programming is broadcast. The number of entries taken during the contest period will determine odds of winning.
- 2) Eligibility. Participation is open to legal residents of the Continental United States, 18 years of age or older. Exceptions include employees of New Media Broadcasters, Inc., their parents, affiliates, subsidiaries, suppliers, advertising and promotion agencies, including, without limitation, prize suppliers, participating advertisers, sponsors or any subcontractors of the above, and family members of anyone so employed.
- 3) Limitations. One prize per name, address or household per contest. Not responsible for contestants' inability to complete their entries during the contest period. Decision of the judges is final. All participants agree to be bound by these rules. Void where prohibited by law. All federal, state and local laws and regulations apply. Winner must be 18 years of age or older to win. If the winner is unable to meet contest limitations, they will forfeit the prize.
- 4) Prizes consists of one of (7) pairs of tickets to the WWE event June 21<sup>st</sup> in Missoula valued at \$70 each or \$140 a pair, or one of (5) pairs of tickets to the WW Event on June 21<sup>st</sup> in Missoula valued at \$95 each or \$190 a pair. Local State and Federal Taxes are the sole responsibility of the winner. Prizes are non-transferable with no cash substitution.
- 5) Claiming the prizes. The prize winners agree to return the completed affidavits of eligibility, indemnification and release forms within seven days of receiving the documents.
